## Terms and Conditions

A deposit paid secures a booking with a completed booking form. This deposit is non returnable. The balance of a booking is payable no less than four weeks before the Weekend/Course/Cruise begins. If the booking is made within four weeks of the Weekend/Course/Cruise then full payment is required upon booking. If you cancel within 28 days of your Weekend/Course/Cruise you will be liable for the full amount.

In the event of your Weekend/Course/Cruise being cancelled, with no suitable alternative available, our liability is limited to payment received and a refund to this amount will be made.

If weather conditions are the reason for postponement then an alternative date(s) will be offered, where possible. An alternative date must be accepted within three months from the original date. We do not provide a refund where weather is the reason for postponement.

Provisional bookings by telephone or e-mail will be held for seven days only. A booking will be confirmed once the correct payment has been received.

The cost of our Weekends/Courses/Cruises includes breakfasts and lunches (vegetarian) unless otherwise stated. They also include the hire of waterproofs if required. Evening meals and mooring fees are not included. Mooring fees are paid between clients when requested by the relevant marine, harbour master etc.

Our insurance policy provides full cover for our yachts and against accident, injury and third party liability. However, should damage, personal; injury or loss result from gross negligence by a client then he or she will be liable for the full amount of replacement or repair. Such negligence includes clients under the influence of alcohol or drugs or as a result of not obeying the instructions of the Skipper.
